He returned back to the United States as one of 35 Black Montford Point Marines to be assigned to Camp Lejune North Carolina. **Rev. Richard P. Warren** served with the Marines until 1952 and in 1953 he served with the United States Air Force. **Rev. Richard P. Warren** served during World War II, Canada, the European and Pacific Theatres and he also fought in the Korean War. He has received numerous awards including the Congressional Gold Medal. **Rev. Richard P. Warren** is recognized for his community service with the Roosevelt Chamber of Commerce, the American Legion Post #1957 and his ministry at Naomi AME Zion Church.
